## Mammoth Lakes Foundation Executive Committee Special Meeting Agenda Action Sheet

**Title:** Mammoth Lakes Foundation (MLF) Support of the Disabled Sports Eastern Sierra (DSES) National Wounded Warrior Center (NWWC).

#### **Recommended Motion:**

It is recommended that the MLF Executive Committee review and consider taking action to approve the lot split, which will create a separate parcel for the stand-alone development of the NWWC and to support an amendment of the Zoning Code to include a use classification for physical wellness and rehabilitation centers in addition to the current uses allowed in the Public and Quasi Public (P-QP) zoning district in the Town of Mammoth Lakes.

#### **Background Information:**

Mammoth Lakes Foundation has been working with Disabled Sports Eastern Sierra in recent years to support the development of the National Wounded Warrior Center in Mammoth Lakes on property owned by Mammoth Lakes Foundation.

#### Lot Split:

The lot split and the zoning amendment are two separate and unrelated processes. The lot split will create a separate parcel on Mammoth Lakes Foundation property for the stand-alone development of the NWWC.

- MLF will work with DSES to complete a recommendation for a lot split through the Town of Mammoth Lakes.
   The lot split will create an independent parcel for the development of the NWWC.
- MLF will submit the lot split application as the owner of the property. DSES will be responsible for the
  completion of the application package and all associated expenses including surveys, drafting services, copies,
  and fees to the Town of Mammoth Lakes.
- Legal fees pertaining to the lot split will be the responsibility of each respective organization.
- The newly created lot will be approximately 2 acres. The exact size and dimensions will be determined by the
  design requirements of the NWWC including setbacks, density requirements of both parcels and building design
  to accommodate topography.
- DSES use of the parcel is restricted to the development of the NWWC.
- The density of the SGSA will be rounded up to maintain conformity to current zoning. The Town staff will confirm this conformity in a written document for the public record.
- Current title report for the subject parcel to be submitted with the application.
- The value of the new parcel is approximately \$800,000.

#### **Options for Consideration:**

- 1. Option 1 take action to support the project on MLF property.
- 2. Option 2 take no action and the project does not move forward on MLF property. If the Executive Committee decides to not take action there is no need to discuss the request to support a zoning amendment.

#### **Zoning Amendment:**

The lot split and the zoning amendment are two separate and unrelated processes. The zoning amendment will amend the Public Quasi-Public (P-QP) zoning district in the Zoning Code to to include physical wellness and rehabilitation centers in addition to the current uses allowed in the P-QP zoning district. The addition of the physical wellness and rehabilitation center use classification will allow for the development of the NWWC and similar facilities to be built with no density restriction as long as they meet the design/function criteria set forth by the Town.

- DSES to submit Zoning Code amendment application to the Town of Mammoth Lakes to allow for physical wellness and rehabilitation facilities in the P-QP zoning district.
- DSES will be the applicant and MLF will be listed as the landowner even though there are many other organizations who own parcels in this zone.
- Submittal package will need signatures from the MLF Board of Directors on the application.
- The site plan for the NWWC Center will be included in the application packet.
- DSES will be responsible for all costs and fees to process the Zoning Code amendment.
- This amendment will provide clarification that the NWWC is a permitted use and is consistent with the Town of Mammoth Lakes General Plan and the Zoning Code as an allowed use in the Public Quasi-Public zoning district.
- This zoning will encompass the entire P-QP zoning district in the Town of Mammoth Lakes to include physical wellness and rehabilitation centers in addition to current uses allowed.
- The amendment will create an allowance for the proposed use classification throughout the P-QP zoning district.
- There will be no impact from this Zoning Code amendment on existing or proposed MLF projects.
- The proposed amendment does not modify the current density limitation of four (4) residential units per acre.
- Without the amendment the Town could propose a similar use interpretation which would require approval from the Town Planning and Economic Development Commission.
- Public notice of the request for zoning amendment will be completed by the Town of Mammoth Lakes through mailings and appropriate public notice.
- Further information will be required from both MLF and DSES as this application is processed

#### **Options for Consideration:**

- 1. Option 1 take action to support the project on MLF property.
- Option 2 take no action and the project does not move forward on MLF property. Even though the lot split and
  the Zoning Code amendment are two separate and unrelated processes, the project is contingent upon both of
  these processes being approved by the MLF Executive Committee to proceed for recommended approval by the
  Town of Mammoth Lakes.

#### The following actions could result as elements of this process:

- a. The Executive Committee could not approve support for the project and DSES would have to secure another parcel for the project.
- b. If approved, MLF will be involved in the process including preparing documents, having documents reviewed and approved by both the MLF Executive Committee and our legal counsel and participation in the public meetings as part of the process.
- c. If these two items are approved through the Town of Mammoth Lakes processes, a lease agreement between MLF and DSES will be required for the parcel and development of the NWWC.
